



## **What's Your Food Story: Holiday Visual Arts Contest Terms and Conditions**

No purchase required. Contest begins **November 23, 2021**. There are **two (2) prizes to be won in two categories. Category one is an 'Individual – school-aged child (Kindergarten to Grade 12) with a \$100 gift card, and category two is a 'Class submission (Kindergarten to Grade 12) with a \$500 prize in art supplies gift card.** Skill testing question required by the parent/guardian of the individual category winner, and the educator for the class submission category winner. Open to legal residents and classrooms of Ontario. Odds of winning will depend on number of eligible entries received before Contest closes.

THIS CONTEST IS ONLY OPEN TO ONTARIO RESIDENTS AND CLASSROOMS AND IS GOVERNED BY CANADIAN LAW AND THE LAWS OF THE PROVINCE OF ONTARIO. NO PURCHASE NECESSARY. SEE BELOW FOR FULL CONTEST DETAILS. ### **CONTEST PERIOD**

- 1) Contest opens **November 23, 2021, 12 a.m. EST** and closes **January 10, 2022 at 11:59 p.m. EST.**

### **ELIGIBILITY**

- 2) The Contest is open to all residents and classrooms of Ontario, except employees (and those with whom such employees are domiciled), Board of Directors (and those with whom such employees are domiciled) of Grain Farmers of Ontario (the "Sponsor"), its affiliated companies or agents, advertising and promotion agencies.

### **HOW TO ENTER**

- 3) **NO PURCHASE NECESSARY.** To participate in this contest you must: a. successfully fill out all questions on our submission form and upload at least one image of child's, student's, or classrooms' artwork to our [submission form](#) before 11:59pm EST, January 10, 2022. Artwork must be representative of the child's holiday themed food story, and image(s) of artwork must be clear and visible. Acceptable art forms can include drawing, painting, collage, paintmaking, textiles, photography, digital media, or sculpture. A high-resolution image(s) of the completed work will constitute a submission, via our submission form. An accompanying artist's, age-appropriate statement should describe the work, but it is not a requirement of the contest submission.



- 4) By entering the contest, participants agree to Grain Farmers of Ontario using their name (or an alias) and photographs of their work for the purpose of promoting agriculture education amongst the community and educators. The chosen entry may be displayed on Good in Every Grain website, social media platforms, newsletters or Grain Farmers of Ontario member magazine and social media platforms.
  - All submitted works must be original.
  - A digital photo of the artwork must be submitted
  - An individual student or class may submit multiple entries
  - Winners will be required to provide permission from parents or guardians for students under 18 for promotion purposes.
  - A title and a brief artist's statement about the holiday food story – as age-appropriate – is recommended but not required.
- 5) Multiple entries are allowed in each category.
- 6) On **DATE OF DRAW**, January 11, 2022  
in Guelph, Ontario, at approximately 10:00 a.m. ET, one (1) eligible entrant from each category will be selected by random draw from all eligible entries submitted via our online form. The odds of winning depend on the number of eligible entries received. The draw will be livestreamed on Good in Every Grain's Twitter account (<https://twitter.com/GoodinGrain>)

- 7) \$500 Art Supplies (Class category); \$100 Gift Card (Individual category)

## GENERAL

- 8) By entering the Contest, each entrant agrees to abide by these Contest Rules. This Contest is subject to all applicable federal, provincial and municipal laws. Void where prohibited by law. The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal.
- 9) Sponsor reserves the right to cancel, suspend, withdraw or amend this Contest in any way, without prior notice or obligation, in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Contest as contemplated by these Contest Rules. Any attempt to deliberately undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.



- 10) All Entries are subject to verification at any time and for any reason. The Sponsor reserves the right to remove any videos deemed to contain inappropriate content, hate speech, political or activist propaganda or content that is offensive. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of the time for the purposes of a valid Entry in this Contest will be the Contest server machine(s).
- 11) Any attempt or suspected attempt to use robotic, automatic, programmed, or otherwise, illicit means to enter the Contest, or any other methods not authorized by these Contest Rules, for example, but not limited to, submitting multiple forms, shall be deemed as tampering and may disqualify you from entering, participating, winning prizes (defined herein), and preclude you from participating in future contests and promotions, at the sole discretion of Sponsor. Entries that are late, lost, illegible, contain false information, are misdirected, garbled or incomplete, or otherwise irregular or that do not conform with or satisfy any or all of the conditions these rules will be judged void. Further, the Sponsor, its advertising and promotion agencies will not be liable for any injury or damage to an entrant's or any other person's computer related to or resulting from participating in the Contest.
- 13) In the event of a dispute, Entries will be deemed to have submitted by the authorized holder of the email address submitted at the time of entry. "Authorized account holder" is defined as the person who is assigned an email address by an internet provider, online service provider, or other organization (e.g. business, educational institute, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. If the identity of an online entrant is disputed, the authorized account holder associated with the email account at the time of entry will be deemed to be the entrant. A selected entrant may be required to provide proof that he/she is the authorized account holder of the email address associated with the selected Entry. The sole determinant of the time for the purposes of a valid online Entry in this Contest will be the Contest server machine(s).
